#### Instructions for completing ECU Credit Approval Details

- Student: You must make a time to meet with your Course Coordinator to discuss your credit approval.

  Please take with you the following documents:
  - o A copy of this form
  - An current course planner (available from the Student Hub enquiries@ecu.edu.au)
  - o The host University syllabus / unit outlines you wish to study
- Course Coordinator: Please see the table below and examples overleaf for assistance on how to complete this form in collaboration with the student.
- The purpose of this form is to facilitate student enrolment and processing of credit upon completion of overseas study.
- Credit can only be given for units that are part of the remaining units in your course planner.
- Students participating in ECU's Student Exchange program must be receiving credit for a full-time study load (minimum of 45 ECU credit points).
- The ECU Unit Code / Elective Level section must ONLY have either an ECU unit code listed OR a specified level of elective credit, ie. Level 1 Elective.
- If the student requires multiple host units to = one ECU unit, or vice versa, this must be indicated on the form. See examples on page 3.
- Approval of units is entirely at the discretion of the Course Coordinator.
- Any changes to approved units once you commence study at the host institute will require submission of a new Overseas Study Credit Approval form.

#### Examples of credit systems in other countries / regions

Credit systems are *not* universal so this is intended to be used as a *guide* only and actual credit equivalency may depend on:

- individual host institution credit system;
- unit content equivalency; and
- credit being sought, ie core unit or elective unit.
